Board of Directors report- N3LBI- No Quorum informal meeting discussed N3ZNP got the water and club house ready for meeting, found the well for the water, website, events, QuaRae editor needed, directory ready and foxhunts.

License Renewal Information

Many Hams may not be aware of a new procedure now in effect for license renewal.

A three step process is necessary for renewal:

1. You must first obtain a "CORES" Federal Registration Number ("FRN"). The FCC relates our Social Security Number ("SSN") to the FRN. This number is permanent. It serves to eliminate further reference to the SSN by the FCC. It helps to preserve the privacy of our SSN. This process also requires the assignment of a password, which can be selected by the Ham, or the FCC will assign a password to relate to the FRN. [FCC Form 160](#) can be used to accomplish this procedure.

2. After the above is completed, the next step is to associate our call sign to our FRN. [FCC Form 606](#) is the appropriate form.

Final step is the license renewal application. [FCC Form 605](#) is applicable.

You say you would rather not do all that paper work? Fine. You can do it all On-Line via the FCC Internet Web Site. It will take about 10 minutes. If you don't compute, call Bob N3FAW. I have done it for several people. I will need your Social Security Number, call and exact name including middle initial.

Any future business with the FCC will use the same FRN and password, so keep the documents which should be printed while on line. They will contain your FRN and password.

FCC Web Site: www.fcc.gov, then click on "FCC Registration Number" in the left column.

HAM-CONGRESSMEN URGE FCC CHAIRMAN'S SUPPORT FOR ARRL RESTRUCTURING PLAN

The only Amateur Radio licensees in the US Congress--Rep Greg Walden, W7EQI (R-OR), and Rep Mike Ross, WD5DVR (D-AR), have written FCC Chairman Michael K. Powell to urge adoption of the ARRL's restructuring Petition for Rule Making (RM-10867) "in its entirety" along with rules changes needed to put it into place. "We believe that this plan will encourage the development, refinement and use of new technologies; increase the number of young people involved in Amateur Radio; and provide incentives for Amateur Radio licensees to pursue technical self-training and opportunities for volunteerism in the best traditions of our country," Walden and Ross said in an April 23 letter. "We urge you to support the ARRL's restructuring plan and to implement it rapidly."

The FCC now is considering a total of nearly 1300 comments filed on the League's restructuring plan and on two other similar petitions--one from a group called the Radio Amateur Foundation, RM-10868, and the other from the National Conference of Volunteer Examiner Coordinators, RM-10870. A fourth

petition from Ronald D. Lowrance, K4SX, RM-10869, dealt solely with the Amateur Radio Morse code requirement. It attracted more than 200 comments before the April 23 comment deadline. The ARRL plan proposes a new entry-level Amateur Radio license--being called "Novice" for now--that would include HF privileges without requiring a Morse code exam, consolidate the current six license classes into three and retain a 5 WPM Morse test only for Amateur Extra class applicants. It also would integrate current Technician licensees into General and current Advanced licensees into Amateur Extra without additional testing. "The ARRL's license restructuring plan, once implemented, will complete the Commission's [restructuring] plan, initiated in 1998, and will provide a blueprint for licensing well into the next decade," Walden and Ross said. The League's plan "is needed right now to promote greater growth of the healthy, exciting and rewarding intellectual pursuit of Amateur Radio." Walden--a member of the House Subcommittee on Telecommunications and the Internet--and Ross invited Powell to share his thoughts on the matter. — ARRL

WUSE 93.9 – US Country— 6,000 Watts Directional—The transmitter is located off Wagner Road on the side that is accessible from Rt. 99.

WFGO 94.7 – Froggy 94.7— 1,700 Watts Omnidirectional —The transmitter is located on Peach Street.
